Searching for this number in the Blueprint Community will display the enhancement ID details. The internal defect tracking number is also included for reference purposes. Legacy Blueprint Version Support

Support has been terminated for the following legacy Blueprint versions: 6.0, 6.1, 6.2, 6.3, and 6.4. If you have any questions or concerns please reach out to the Blueprint Support Team.

SQL Server Support

Support will be added for Microsoft SQL Server 2016. If you have any questions or concerns please reach out to the Blueprint Support Team.

Rapid Review Replacement

Rapid Review is still available and can be created from Collections, however, it is deprecated and will be removed in a future release as the new Review Experience replaces it. Blueprint Enterprise customers should note that Rapid Review has been replaced by the new Review Experience in Storyteller.

Implemented Enhancement Requests

This release introduces several changes:

- **Cross Project Copy:** Trace relationships if both ends of the trace are within the copy scope and attachments/document references are preserved when copying artifacts across projects (<u>ER-1728</u>).
- **Generated Office Documents:** Review approval summaries, including Electronic Signature (if applicable), are now included in generated office documents. (<u>ER-2040</u>).
- Revamped Reviews (Improved Usability): All artifacts are shown at once and buttons are more clearly



labeled (ER-1636).

- Revamped Reviews (Faster Creation Time): Revised Review functionality allows for quick Review
 creation times based on any kind of artifact grouping (Baselines, Collections, and loose artifacts) (ER2028).
- Revamped Reviews (Universal Format): All review management and view features (including sign off)
 are available in a universal format (<u>ER-1985</u>).
- Bulk Actions Approvals in Reviews: All artifacts in a Review can be approved at once through bulk actions (ER-1777).
- Text Wrapping: In live artifacts and Reviews, any text that extends beyond the viewable area will wrap (ER-1634).
- Artifact Specified URLs in Reviews: As you are scrolling through a Review, the artifact ID in the URL will change to that of the artifact that is currently being viewed. This view will be perserved when sharing the URL (ER-2032).
- **Changed Artifact Indicator in Reviews:** When artifacts that are contained in a Review change, the Review table of contents will display an indicator next their names (<u>ER-2405</u>).
- Expiry Date Included in Review Notifications: Review participants receive an email notification
 when a Review requiring their participation is activated. This email includes the expiry date if the Review
 manager has set one (ER-1654).
- Traces Within Same Artifact: Sub-artifacts within the same artifact can contain traces to one another (ER-2019).
